-3.	I accept and understand that the purpose of Nitrous Oxide is to make it more comfortable for my child to receive the necessal dental care with less pain and/or arxiety. General Anaesthesia: Commonly GA, a child under general angesthesia has no awareness and must have his/her breathing temporarily supported. General anaesthesia is appropriate for more invasive procedures.	
6.	The use of Nitrous Oxide has been fully explained to me, including all risks involved. I have been fully informed that tempora complications may include, but are not exclusive of: tingling in the fingers, toes, cheeks, lips, tongue, head or neck area; heaviness in the thighs/or legs, followed by a lighter floating feeling; resonation in the voice or presence of a hyper nasal tone warm feeling throughout body, with flushed cheeks; episodes of uncontrollable laughter or giddiness; detachment or disassociation from environment may occur; intense and uncomfortable ward and/or hot feeling throughout body; lightweigh or floating sensation with an accompanying "out of body" sensation; sluggishness in motion and slurring and/or repetition of words; feeling of nausea; vorniting; agitation; and hallucination. All these complications are temporary.	i.
